Meeting called to order at 12:04 p.m.

- 1. <u>Treasurer's Report</u>:
 - Barb handed out the March Monthly Financial Report.
 - -M/S/C to approve the report as submitted by Nate and Robbin.
- 2. <u>Secretary's Report</u>:
 - The March meeting minutes have been posted online.
 - -M/S/C to approve the minutes by Nate and Robbin.
- 3. <u>Chief Stewards' Reports</u>:
 - Carol is not here. She's dealing with one item.
 - Jody has nothing.
- 4. <u>President's Report</u>:
 - MN Union Women & Femmes Retreat:
 - April 19-21 in Brainerd Lakes Area.
 - -Too expensive to attend.
 - St. Paul Regional Labor Federation Labor Bowl:
 - -Thurs., April 27 in St. Paul.
 - They're asking for cash donations.
 - -Can sign up to bowl by April 20.
 - -Need to raise \$100 minimum to participate.
 - Money helps union members with financial issues/grievances. Great program.
 - -Great program.
 - Adam, John, and Lynne are working with HR regarding range movements.
 - There's about 10 staff who had no raise this year at top of their pay plan.
 - -County said they took care of in 2015. Froze top end staff so lower end could catch up with them.
 - We say no, start fresh this year. We were under interpretation that all of us were getting a raise for 2017.
 - -County never stipulated these 10 positions at their max range wouldn't get a raise.
 - -Had MOU but it said extend contract 1 year.

-Start conversation on this; waiting for future dates.

- -County can either fix this or grieve it. This could go to arbitration. We expect the staff to get back pay.
- Christy Harriman, who was elected our Vice President, left Washington County so the VP position is open.
 - Angie Plumbo is interested in the VP position.
 - -Lynne will check into appointing Angie through the E-Board at the April E-Board meeting.
- 5. Business Rep. Report:
 - MAC (Member Action Center) goes live 4/25/17.
 - -Our rep., John, no longer has voice mail; his calls go to the MAC.
 - -6 staff take calls at the MAC.
 - If the call is grievance related, staff will connect you to the appropriate person.
 - This will help free up time for the reps.
 - If you call John's cell #, you'll get John.
 - Bargaining with City of Stillwater:
 - -Proposal to red circle 1/3 of members above new market set.
 - -Singles pay 10%.
 - In 2018, now 6 steps to top then longevity. Propose to get rid of longevity and move to 11 steps. Staff upset.
 - -Waiting on appeals.
 - Proposed 1 year contract employer agreed if singles don't pay, go to mediation.
 - -Met with workers last week go back to table with single's paying something.
 - -Lock into 1 year gets us to this fall.
 - City of Stillwater Library up comp. study too.
 - John has 9 contracts to handle this fall.
- 6. Old Business:
 - Bank account:
 - -Talked about switching from current U.S. Bank to Lake Elmo Bank.
 - -Barb will do a cost comparison and bring to E-Board meeting.
 - -Close old account, open new account, CD, etc.
 - Nice to have all at one bank.

 - Woodbury's custodian, Gus (James) Wilks, is back to work.
